

1. Andalucía

- [Law 1/1998](#) of 20th April on the rights and welfare of minors (Article 2 – protection of rights; Art. 7 – information and advertising) – ensures that in social media – programmes or advertising contrary to the rights of minors cannot be disseminated – and must not contain discriminatory, sexist pornographic or violent elements.
- [Decree 25/2007](#) of 6th Feb, establishing measures for the promotion, risk prevention and security in the use of the Internet and Information Communication Technologies on the part of minors. The Decree essentially protects minors on the internet and refers specifically to videogames in Article 13 (Rules of safety and security – in reference to Internet and e-commerce).

2. Aragon

- [Law 12/2001](#), of July 2, on childhood and adolescence in Aragon
 - It prohibits videogames for minors that contain pornographic, violent, xenophobic, sexually discriminatory or criminal content – as well as prohibiting such content being advertised in places where minors might be (See 42.3 and 44.3)
 - Article 42: Print and Audio-visual media; Article 43: Advertising aimed at children and adolescents; Art. 44: protection before use/ consumption.

3. Balearic Islands:

- [Law 17/2006](#) of November 13, on comprehensive care and the rights of children and adolescents in the Balearic Islands (Article 42.1 and 42.2 – Prohibitions and Restrictions) Prohibition on the sale, rental, presentation or offering to minors of games/ videogames or other products that contain pornographic and violent content
 - Section 13 (Information and Advertising): Art. 45 (Advertising); Art 46 (Advertising on TV); Art. 47 advertising in which minors participate)

4. Canary Islands

- [Law 1/1997](#) of 7 February, providing comprehensive care for minors (Art. 35.1 and 35.2 – Audiovisual Media)
 - Art. 35.1: Prohibited - sale and rental to minors of videos, video games, or any other media that contain messages of a violent nature, justification of any form of crime, pornographic display, or contrary to the rights recognized in the Constitution, and screening at venues or shows in which minors are allowed to attend. And prohibition of advertising messages contrary to the rights recognised in the Constitution.
 - Art. 36 (Advertising aimed at minors); Art. 37 (Advertising carried out by minors)

5. Castille La Mancha

- [Law 5/2014](#) 9th Oct, on the social and legal protection of children and adolescents
 - (Art. 125(m) – ref videogames)
 - Art. 24: Protection of children from certain activities, media, and products.

6. Castile-Leon

- [Law 14/2002](#) of 25 July, on the promotion, care and protection of children in Castile and Leon (Art. 32.1 and 32.3)
 - Chapter III: Art. 32: Audiovisual media and Telecommunications; Article 33: Advertising

7. Catalonia

- [Law 14/2010](#) of 27 May, on the rights and opportunities of infants and adolescents
 - Chapter 9 – Advertising and social media and shows (Arts 59 – 64)
 - Article 63: included as prohibited: advertising messages contrary to the rights and fundamental freedoms recognized by the existing law, which incite violence and criminal activity, consumption of substances that can lead to addiction, any kind of discrimination or pornographic content.

8. Valencia

- [Law 12/2008](#) of 3rd July 2008, from the Government, on comprehensive childhood and adolescent protection.
 - Art. 68: Prohibits the promotion of videogames via messages that contain pornography, justifying it – any type of crime, glorification or incitement of violence, xenophobia or discrimination that results in harming the personal development of minors and contrary to the rights and freedoms recognized by the current law.
 - Art. 73: Advertising aimed at children; Art. 74: Advertising in which children feature; Article 75: Prohibitions in relation to advertising and the protection of children.

9. Galicia

- [Law 3/2011](#) – on family support and coexistence in Galicia. (Art. 43 – Prohibitions in relation to publications and audiovisual media) Chapter II – Rights and Duties (Arts 42-45)

10. La Rioja

- [Law 1/2006](#) of 28th Feb on the protection of minors (see Chapter III – Arts 21-28)
 - Art. 24 and 27 – prohibits promotional content which is violent, contains criminal acts or pornography.
 - Art. 26: Advertising aimed at children

11. Madrid

- [Law 6/1995](#) of 26th March, on guarantees for rights of children and adolescents. (Chapter II – Protection before advertising and consumers; Arts 36-40 – includes advertising aimed at minors (Art. 36) and advertising featuring minors – Art. 37) Prohibits the sale of videogames to minors that contains violence, sexual acts, porn, justification, or is contrary to the rights recognised in the Constitution (Art. 33 – prohibited activities – audiovisual media).

12. Navarre

- [Floral Law 15/2005](#) of 5th Dec on the promotion, welfare and protection of children and adolescents.
 - Art. 99.12 (Serious offences) – ref. sale, rental of videogames
 - Title II – Rights of minors; 2nd Additional disposition – Advertising and TV programmes

13. Basque Country

- [Law 3/2005](#) of 18th Feb on the welfare and protection of children and adolescents
 - Art. 30.1 and 31 – prohibits the sale or rental of videogames with violent content, pornography or abuse of personal relationships, reflecting degrading treatment, inciting criminal activity or encouraging a lack of solidarity or discrimination on grounds of birth, age, race, sex, marital status, sexual orientation, physical or mental fitness, health, language, culture, religion, belief, ideology or any other condition or personal, economic or social circumstances or have any other content likely be harmful to their development.
 - Art. 31: Audiovisual Media; Art. 32: Protection from Advertising

The following regions do not have any provisions related to advertising within their child protection legislation:

- **Asturias:** [Law 1/1995](#) 27th Jan on the protection of minors
